


KEY NOTES:

- 1. TOILET Z0002 EQUAL TO 3.15 NSM [34 NSF]
- 2. 3'-8" MINIMUM DOOR WIDTH. SECLUSION & TOILET ROOM MUST SWING OUT.
- DOOR SHALL NOT HAVE PROJECTING HARDWARE ON SECLUSION AND TOILET ROOM SIDE.
- 4. DOOR SHALL HAVE VISION LITE WITH INTERNAL BLINDS, CONTROLS ON ANTE ROOM SIDE. GLAZE WITH POLYCARBONATE SHEET.
- 5. PROVIDE IMPACT RESISTANT POLYCARBONATE SHEET OVER WINDOW GLAZING OR COVER WITH SCREENS ON INSIDE.
- 6. BOLT BED TO FLOOR FOR MAXIMUM SECURITY. CHECK WITH FACILITY.
- 7. LOCKABLE DOOR FROM ANTE ROOM SIDE
- ELECTRICAL OUTLETS ARE PROHIBITED IN THE SECLUSION ROOM AND TOILET.
- 9. ROOM DOOR SHALL BE LOCATED FOR DIRECT STAFF SUPERVISION.
- 10. SIZE WINDOWS TO THE MAXIMUM ALLOWED BY NF-3-400-01 (LATEST EDITION). DESIGN: ENERGY CONSERVATION & ASHRAE 90.1 (LATEST EDITION) ASHRAE ENERGY STANDARD FOR BUILDINGS EXCEPT LOW-RISE RESIDENTIAL BUILDINGS, BUILDING ENVELOPE REQUIREMENTS APPENDIX B






- 1. SECURITY LIGHT FIXTURE. ALL EXPOSED SEAMS TO BE CONTINUOUSLY WELDED. ONE PIECE DOOR WITH CONTINUOUS PIANO HINGE. FULLY RECESSED CAPTIVE FASTENERS. LENS TO BE ACRYLIC AND SECURED TO PREVENT REMOVAL. SECURITY MOUNT TO CEILING TO PREVENT FIXTURE REMOVAL.
- 2. RECESSED CAMERA BEHIND PROTECTIVE POLYCARBONATE SHEET FOR MONITORING PATIENT FROM CONTROL STATION. VERIFY POWER REQUIREMENTS WITH USING SERVICE.
- 3. HVAC SUPPLY, RETURN AND EXHAUST GRILLES SHALL BE SECURITY TYPE CONSTRUCTION TO PROHIBIT REMOVAL FROM THE FRONT OF THE GRILLE.
