## Green Building Certification Standard Update (Major Projects)

**NEW STANDARDS:** To support compliance with CFM Policy 003C-2021-21, Green Building Certification Requirements, the following design criteria are effective immediately.

1. If a major construction project includes a new building, or the renovation of an existing building, it must be designed to achieve Silver-level certification under the Leadership in Energy and Environmental Design® (LEED®) certification system managed by the U.S. Green Building Council® (USGBC®). This requirement applies to all buildings of 1,000 Gross Square Feet (GSF), or greater.
2. If a building does not meet the Minimum Program Requirements for LEED certification, a waiver must be submitted to the Associate Executive Director, Office of Facilities Planning (AED OFP) for approval.
3. During all design phase submissions, include a *CFM Sustainability Scorecard* for every building in the project. A sample *Scorecard* can be found in Attachment 2 of this *Alert*. A fillable version of the document is available on the Sustainable Design page of the VA Technical Information Library (TIL).
4. The designer of record must register each building in LEED Online® as early as possible in the design process, and no later than the submission of Design Development Phase One (DD1) submittals. List "U.S. Department of Veterans Affairs" as the owner when registering a project in LEED Online. Following registration, provide notification to [SustainableDesign@va.gov](mailto:SustainableDesign@va.gov).
5. Utilize the LEED rating system most appropriate for the building being designed. If the overall project is eligible for certification as a Campus, Campus certification may be used. In such cases, all buildings included in the Campus will be considered certified upon receipt of final certification.
6. Design teams are encouraged to pursue a certification level higher than Silver whenever a business case review indicates a benefit to the Government.
7. If a design is projected to fall short of the requirements for LEED Silver certification, a waiver request must be submitted to AED OFP for approval of a downgrade to LEED

Certified. If a waiver has been approved and a design is then projected to fall short of the requirements for LEED Certified, notify the VA Project Manager, Contracting Officer, and AED OFP immediately, and submit a waiver request to AED OFP for approval.

8. The designer of record is responsible for submitting all documentation for certification review by USGBC.
9. Provide a copy of the final certification to: 1) The VA Project Manager, 2) the facility Real Property manager, and 3) the CFM Sustainability Program at SustainableDesign@va.gov.

**ADDITIONAL INFORMATION:**

1. All construction design efforts underway prior to the issuance of CFM Policy 003C2B-SA-002A, Green Building Certification Requirements, are encouraged to transition to the criteria shown in this *Alert*, if feasible.
