- SpecsIntact features new Supplemental Address List to automatically add local Reference Address to Section 01 42 00 'Sources for Reference Publications' for new Jobs.
- ♦ Streamlined SpecsIntact executable installation.
- ♦ New Section Summary Comments to manage Section Editing.
- Use Revisions when Renaming Sections.
- SpecsIntact supports loss of display monitor while running.
- New option to use Section headers and footers for reports and Project table of contents.
- SI Editor retains and reuses previous zoom settings.
- Editor automatically completes typed Tailoring Options and scrolls listed options into view.
- Editor retains vertical scroll position when undeleting redlines.
- Editor Validates for Reference Identifiers and Submittal Items with too many characters.
- Editor adds brackets around sample text inserted with new tags.
- SI Editor's 'Remove Tags' command (CTRL+M) available while editing Formatted Tables.
- Future UFGS may support enhanced Submittal Reconciliation.
- ♦ SI Explorer correctly handles saved Section comments.
- ♦ Formatted Tables published to Word in correct locations.

Big changes on the horizon!

With the departure of the National Aeronautics and Space Administration (NASA) from the Tri-service Unified Facilities Criteria Program, all Unified UFGS Sections where NASA was the Preparing Activity (PA) have been reassigned to one of the other Tri-Service Agencies. As part of this change, NASA will be removed from the Master specifications headers along with all NASA references and Tailoring Options. This effort began with the August 2023 Release and is targeting completion by the February 2024 Release.

UFGS Changes and Revisions

Did you know that you can research the historical changes for the UFGS Sections? The National Institute of Building Sciences (NIBS) Whole Building Design Guide (WBDG) Website has released the '<u>UFGS Changes and Revisions</u>' Tool that will allow you to lookup the changes for a particular release or for individual Sections.

In order to assist our customers SpecsIntact offers two convenient methods to easily access the UFGS Changes and Revisions Page and the UFGS Section History. To access the UFGS Changes and Revisions from the SI Explorer go to the **Help** Menu and *select* **UFGS Changes and Revisions**. To View the history of a particular UFGS Section, from the SI Explorer, select a Section and then go to the **Sections** menu or *right-click* and *select* 'Change/Revision History'...'

Criteria Change Request (CCR)

SpecsIntact also provides the capability to easily submit a Technical or Non-Technical change for a UFGS Section. To submit a CCR through the SI Explorer, select a UFGS Section, go to the **Tools** Menu or *right-click* and *select* '**Submit UFGS CCR...**'
